

NATIONAL DIABETES SERVICES SCHEME (NDSS)

The National Diabetes Services Scheme (NDSS) is administered on behalf of the Australian Government by Diabetes Australia under a five year agreement. The scheme has been running since 1987 and Diabetes Australia has been the administrator through a series of agreements. The Scheme is managed by the Department through the Pharmaceutical Access and Quality Branch, Medical and Pharmaceutical Services Division.

The NDSS provides access to products and services needed for the self-management of diabetes at prices subsidised by the Australian Government. The products include syringes, insulin infusion pump consumables and glucose testing reagents.

The number of persons with diabetes registered with the NDSS increased by 7.08 per cent in 2006-2007 compared with 8.66 per cent for 2005-2006. Details of registrant numbers are as follows:

The chart on the following page shows the NDSS expenditure from 1992-1993 to 2006-2007.

The Government provides considerable direct support to people with diabetes through the supply of essential medicines under the Pharmaceutical Benefits Scheme and through the NDSS. In the 2006-2007 financial year, Australian Government outlays on diabetic supplies amounted to \$378.1 million, an increase of \$43.4 million over the previous financial year.

The Australian Government expenditure on the NDSS for the 2006-2007 financial year was \$113.8 million, an increase of \$9.3 million over the previous financial year.
